Remarks:

- ❖ The various dates and times listed above will be strictly enforced. Exhibitors are advised to adhere to the above-mentioned times and dates.
- ❖ Exhibits may be delivered to the stand earlier than the time specified if construction (in the case of "Raw Space" stands only) has progressed sufficiently to receive the exhibits. Please liaise with the official freight forwarder for such arrangements. Exhibitors must be present to receive such exhibits.
- ❖ **Cargos should not be consigned directly to the exhibition hall or venue.**
- ❖ Exhibitors, their agents or stand builders are responsible for the early installation of their heavy or large exhibits according to the move-in schedule provided by the Organiser / Official Stand Builder. When stand structures are erected, it may not be possible to move-in / install heavy and large exhibits that arrive late. With that, we are highly encouraging exhibitors to engage in the Official Freight Forwarder's service.
- ❖ Please note that Official Freight Forwarder must be appointed for mechanical handling within the exhibition hall. Forklifts, cranes and pallet trucks from exhibitors and other forwarders will not be permitted into the Exhibition Hall.
- ❖ Except light hand-carried exhibits / goods permitted to be carried into the hall by the main entrances, all other exhibits and heavy goods must be moved in and out by the freight and cargo entrances.
- ❖ The hand - carried exhibits or goods to be brought into the exhibition hall by all individuals and will not be charged by the official on-site handling contractors. These items or goods must be less than 100 kilograms and can be brought in by a small hand trolley.
- ❖ Exhibits arriving on site without a pre-appointed Freight Forwarder will be referred to Official Freight Forwarder by the Organiser. All costs incurred will be borne by the exhibitor.
- ❖ Exhibitors are advised to commence packing their exhibits and belongings as soon as the exhibition ends on the last day. Arrangements with the freight forwarders will have to be made in advance. Dismantling of certain shell scheme stands will commence immediately upon exhibition closing. Exhibitors are advised to remove any items for display from the walls if they wish to keep them.

WORK REGULATIONS & TECHNICAL MANUAL INSIDE THE EXHIBITION HALL OF IMPACT EXHIBITION CENTER

REGULATIONS AND ATTENTIONS

Badges & Attire

1. To work in the exhibition hall, all exhibitors and contractors shall wear the valid work pass or exhibitor badge for checking. The valid passes will be issued by organiser.
2. Exhibitors and contractors must wear proper uniform or attire, covered shoes, safety helmet (when applicable) during move-in and move-out.

Exhibition Hall Wall and Floor

3. Drilling, cutting, nailing, boring, fixing, pulling, painting on the exhibition hall's display board, partition, floor and wall are prohibited.
4. It is strictly prohibited to apply any kind of glue or any other materials alike on any floor, wall, and any structure of the venue except for cloth tape (one-sided or two-sided). Any damages shall be the responsibility of the exhibitors or contractors and shall be subjected to a fine.
5. The exhibitor or contractor shall, for the construction of a stage or any decorative activities, cover the floor of the venue to protect it from any scratch. Details of which are as follows: Plastic sheets or carpets shall be required in case of structure painting. In case where the paint is found on the floor of the building, the exhibitor or contractor shall be subjected to a fine.
6. Exhibitors and contractors must take the appropriate measures to protect the exhibition floor from potential damage when transporting items and equipment's into the exhibition hall.

Fire-Safety

7. Smoking is strictly prohibited in the exhibition hall for fire prevention.
8. No open fire or welding is allowed in the exhibition hall. No inflammable, explosives, poison, and corrosion shall be allowed to be brought into the exhibition halls.
9. Booths must be equipped with fire extinguishers inside closed meeting rooms, closed warehouses, and areas using electrical equipment that generates heat. The fire extinguisher must remain effective, placed in a visible and accessible location, and positioned before 12:00 PM on the last setup day.



10. Inflammable, explosive and strong corrosive items are prohibited at the booth construction site. Working with naked fire, environmentally hazardous solvents, coating, and gas are prohibited. Flammable substances like gasoline; petroleum; oil; alcohol; ethanol; industrial gasoline; aromatic gasoline and so on; Or flammable gas like hydrogen, oxygen, acetylene and so on; or poisonous gas like chlorine, ammonia and so on.
11. Any blocking or disabling of firefighting devices, electrical installations, and sprinklers, scanning probes, emergency exit doors and all public passages are strictly prohibited. Fire-resisting rolling shutter must remain unblocked to ensure smooth operation at any time.
12. No putting of build-up material and construction devices on hall walls; partitions; near doors; or fire extinguishers at IMPACT.

Water Supply

13. **Please note that the water supply needs to be ordered from A-Plus.**
14. Exhibitors must treat the water temperature to room temperature before draining. In case of damages, exhibitors will be penalized.
15. Exhibitors who order only water inlet/outlet must bring the grease trap tank as well. In case the water is contaminated with chemicals, exhibitors must do a wastewater treatment before draining.

Electrical Supply

16. It is strictly prohibited to use electricity from any electric outlets not designated or permitted by venue. Failure to do so shall be subject to a fine. In constructing process, it is strictly prohibited to use electricity from any electric outlet at any walls or pillars inside the building. The venue shall have a cut-out (circuit breaker) installed particularly for construction purposes. The said equipment shall only be ordered from Utilities Management (A Plus)
17. All equipment should have independent neutral & earth for equipment that require three phase power supply.
18. All exhibitors are encouraged to retest the incoming voltage before commissioning their equipment.
19. Exhibitors whose lighting fixtures are found to have been the cause of trips in power supply will be responsible for all re-energisations.
20. Exhibitors are encouraged to use UPS to prevent any immediate interruption of power supply in the event of tripping and stabilizers for sensitive equipment.
21. **Each individual power point or isolator is to be restricted for the use of only 1 (one) piece of equipment and it cannot be used for lighting purposes.**
22. The organiser & A Plus reserves the right to request Exhibitors to change any wiring installation, connection etc. contained in lighting fixtures for safety reasons.



General Painting

23. It is strictly prohibited to use, both inside and outside of the exhibition hall, any spray or paint which contains a thinner or any inflammable substance. Inflammable materials remained from the construction such as thinner and gasoline shall never be left in the exhibition hall during the exhibition period.
24. It is strictly prohibited to dispose paint, wash all kinds of containers, and tools in any toilet inside the venue. Each failure to do so shall be subject to a fine.
25. No pouring of water, paint or any liquid to the floor and technical trench.

Working from Height

26. For those who are to ascend (higher than 2 meters) for work shall put on safety caps, safety belts as well as other necessary safety protection measures. It is prohibited to use herring bone ladders for up to 2m.
27. Scaffolds shall be required for any work at a place higher than 2.00 m. Scaffolding wheels or feet must be padded with soft material before starting work.
28. It is prohibited to use movable scaffolds without guardrail on the top or with guardrail lower than 1.2m on the top. The ladder/movable scaffolding must be in four-wheel-locked status when working on from height.
29. Contractors are required to wear safety shoes and buckle safety belt while performing elevated work more than 4m high.

Power Tool Operations

30. Circular saws are prohibited inside the venue; but a small electric saw is allowed to be used with wood, glass, and tiles. In case where the sawing activity brings about an excessive amount of dust, the venue shall be able to stop the work and make provisions for a working area outside of the venue.
31. Any activity causing fire spark e.g. welding, grinding, cutting, or polishing metal inside the venue is strictly forbidden.
32. All building materials must be prefabricated outside of the exhibition hall. It is a requirement to cover the floor, wall, and partitions in the exhibition hall before doing any painting, sawing, cutting etc.



Additional Information

33. **All food and beverages must be purchased from IMPACT.** Otherwise, a fee will be charged for bringing in outside food. Foods and beverages from outside caterer or supplier shall never be brought into the Exhibition Hall unless permitted in writing by the Venue. Failure to do so shall be subject to a charge of 50,000 baht (Fifty Thousand Baht)/booth/day.
34. Pulleys, structures, or signages with truss structure can be hung onto the building beam which can carry the weight of up to 1,000kg per hanging point.
35. Please contact PX Systems for the hanging points plan. Ensure that the weight and the location of the hanging points match the hanging points plan before forwarding to PX Systems for their review with IMPACT.
36. The use of any amplifier and loudspeaker, lucky draw, sales of alcohol beverages, etc. in an area of the event are controlled by laws or Alcohol Control Act, The exhibitor shall seek permission from an Administrative District, Province, or any concerned authority in advance. Evidence of the permission signed by the authorized authority must be presented to the venue prior to the day of the event.



Any activity involving sound equipment or image projection must not disturb or cause inconvenience to neighboring booths. The volume of such activities, including playing music or using sound systems, must not exceed 70 decibels.

37. Exhibitors shall take good care of personal valuables and exhibits (cell phone, camera, portable laptop, special exhibits and so on) for security work during the exhibition. No littering is allowed. Exhibitors shall keep the exhibition area clean and tidy. No High-pitched sound system is allowed.
38. Exhibitors and their commissioned contractors must take the construction materials and garbage (such as decoration debris, KT board, carton, packaging materials, etc.) away from the display area within the allotted time, the items still left at display area after move-out will be treated as garbage, and the cleaning costs incurred should be paid by exhibitors.



IMPORTANT REGULATIONS

RAW SPACE CONSTRUCTION RULES

1. **All raw space booth designs must be submitted & approved by the organiser and the venue before 2nd October 2025.** Unless a written approval from the organiser is received, exhibitors and contractors are not allowed to begin any stand construction.
2. The appointed Contractor must submit the design according to the rules and regulations and to pay for all related fees. The Contractor must follow the rules during construction, no regulations shall be violated and shall cooperate with inspection by the organiser, official contractor and/or venue.
3. Each Exhibitor is responsible for their own walls. Where stands are adjacent, an exhibitor may not use the reverse side of the neighboring stand's wall. Display of Exhibitor's name, logo, etc. is not permitted on the back or sidewalls of neighboring booths. Using the structure of the exhibition hall or neighboring stands to stabilize is forbidden.
4. **All partition wall(s) between adjacent exhibitors above 2.44m must be fully covered, painted white and have a well-finished surface.**
5. For any construction of height between 3.50-5.00m., the exhibitor or contractor shall sign a consent form stating the consent to any liability arising from any kind of damage.
6. In case the height of the construction is between 5.00-7.00m., an engineer designing the structures and supervising the construction shall sign a copy of a certified engineer's license stating his/her consent to any liability arising from any kind of damage. If there is no such engineer signing the consent form, the venue shall issue a consent letter stating his/her consent to any liability arising from any kind of damage and have it sent to the Venue at least 7 working days before entering the premise. Exhibitors and contractors must obey the timetable of site operations and on-site command and dispatches from official staff. Early move-out is not allowed.
7. Carpet or another floor material must be laid on to the contracted floor space. Inclines toward public aisles must be set within the assigned booth area during the booth construction, to avoid any damage to the public because of the height difference between the platform and the ground.
8. Booths must use flame retardant materials (dale, chemical & blended fabric, drapery etc.) for booth decoration. High power Iodine tungsten spotlight is prohibited. Neon light shall be avoided.



9. Whether for booth or exhibit fixing, no nailing, drilling on the floor, pillars or walls will be allowed, adhesives and glues on the floors, pillars or walls will be strictly prohibited. Exhibitors shall be liable for all costs arising from restoring or repairing facilities. Exhibitors are responsible for any misbehavior of their staff and the staff of its official contractor.
10. Be sure to use shatterproof glass to decorate the booth. To ensure the intensity and thickness of the glass, the thickness of the glass should be more than 8mm. The installation of the glass should be reasonable and reliable.
11. Only metal frames or hardware can be used to install the glass. Ensure flexible materials are used for cushioning between the frame/hardware and glass to assure the security of the glass. Clear notes should be stuck on the glass material for public safety.
12. When using a glass floor platform, the structure-support columns and the walls must be fixed underneath the platform and not on the smooth glass face directly.
13. Exhibitors are not permitted to display, hang, or distribute any exhibit, material, furniture, or product, nor extend their structures and fittings, beyond their contracted boundaries. And unless permitted by the Organisers /Official contractor, no exhibitor shall be allowed to hang any decorations or other articles up to the height limit to the decoration or the surrounding banisters of the second floor of the exhibition halls.
14. Electrical materials used in operation shall be qualified by the examination of the relevant authorities. Fire-resistant cables and insulation casing must be used during wiring works; insulation porcelain and plastic connectors must be used during branch circuit connections. Aerial laying must be used when laying the wires and ground-laid wires must be protected by bridge plates (cable ramps).
15. Erection of partitions or display boards which could hamper the firefighting system and the air conditioning diffusers and air flow inside the exhibition hall are not allowed.
16. All entrances and exits must remain open and clear. Booths or exhibits are not allowed to block the passages and entrances which are designated by the Organisers and venue. In case of violation of such rules, the Organisers / Official Contractor / Venue and/or fire safety bureau reserve the right to adjust and reconstruct such booths and all charges are to be borne by the exhibitors.
17. The Organisers reserved all the rights to modify, adjust and dismantle booths which do not meet requirements. Any additional cost involved would be borne by the exhibitor or contractor.

To assist the approval of importation by Royal Thai Customs, please provide 2 (two) copies of descriptive/illustrative brochures together with your Commercial Invoice/ Packing List.



DEADLINES

a. DOCUMENT DEADLINES:

The shipping documents must be sent to us not later than the deadlines given below or at least 3 (three) days prior to the arrival of vessel and/or aircraft in Bangkok.

Controlled cargo (FDA or TISI license)

- Sea freight: **1 September 2025** Air freight: **1 September 2025**

General cargo

- Sea freight: **15 September 2025** Air freight: **22 September 2025**

***2 originals and 3 copies of Bill of Lading/ Airway Bill, 3 originals and 2 copies of Commercial Invoice, 2 originals and 3 copies of Packing List, 1 copy of Insurance*

*Policy and 1 copy of invoice for the premium if insured at origin***

A pre-alert message via e-mail or fax, indicating consignment details such as the flight numbers, Airway Bill numbers, number of packages, weights and dimensions, is required to be provided to us upon uplift of the consignment.

b. CONSIGNMENT DEADLINES:

- Sea freight: **22 September 2025**

- Air freight: **29 September 2025**

Consignment arrives after the above deadlines will be subjected to 30% Late arrival surcharges (based on the basic handling rate) to cover our extraordinary efforts to speed up clearance of your consignment before the show opens. But we will not guarantee delivery date for your late arrival consignment

INSURANCE COVERAGE

It is the responsibility of each exhibitor to arrange Marine (Transport) Insurance covering all transport you may have in Thailand

Our liability will be limited as per our Standard Trading Conditions as our tariff is computed on the basis of volume or weight and has no correlation with the value of exhibits, it follows that the cost of insurance cover is not included in our charges. In the event that you want us to cover insurance on your consignment, a written instruction must be given to us.



CONTROLLED GOODS

Exhibitors are advised to contact us as soon as you have signed to participate for the exhibition as there are many items required for import license, to be approved before arrival of consignment in Bangkok.

Failure to have import license available, a high Customs fine/ penalty will be imposed on exhibitors.

Here are some items that require Import & Export license prior to their importation into Thailand for exhibition purpose:

Electric Appliance (such as TV, lighting, etc.)	Food & Beverage

All these goods must be re-exported at the end of exhibition.

Exhibitors are to furnish to us the details of the items such as brand, serial number, ingredients or materials made of for each item that you intend to import into Thailand at least 45 days prior to the arrival of shipment.

We will store your empty cases within the exhibition site under shelter during the exhibition if space is available.

For wooden cases returning to some European & Asian Countries at the end of exhibition, they will be required for fumigation before they can be exported as per import regulation of destination country. A fumigation fee will be charged to your account. (if required)



ATA Carnet

Exhibitor who wish to import their exhibition goods temporary into Thailand by using ATA Carnet document. Please make sure that the ATA Carnet is issued accordingly as below:

On the LEFT hand side of ATA Carnet Cover Page:

Column B “Represented by”: **APT Showfreight (Thailand) LTD, and/or any other Authorized Rep.**

Column C “Intended use of goods”, please listed all conditions that your Chamber of Commerce has committed under ATA Carnet: For example, ATA Carnet from France to list: “Professional, Exhibition Goods, Commercial Samples” in this column.

On the RIGHT hand side of ATA Carnet Cover Page:

Column C “Valid Until”: expiry date must have at least 6 months from date of arrival of goods.

At the bottom of ATA Carnet Cover Page

Signature: Please make sure that the same person who sign on ATA Carnet, is the same person to sign on Power of Attorney. If there is any company seal/stamp on ATA carnet, the same company seal/stamp is also required on the Power of Attorney (See Appendix B), is required by Royal Thai Customs.

LANGUAGE: Please use only “ENGLISH” language in ATA Carnet.

As per customs regulation on ATA Carnet shipment, shipment **MUST** be packed and shipped separately from Permanent import items or different type of temporary import items. Please issue Commercial Invoice for Permanent import items. Separate HAWB/ HBL need to be issued for each shipment.

COURIER SHIPMENT

We do not recommend sending shipment via courier service (such as DHL, FedEx, UPS, or SF Express), as they may be detained by Thai Customs. This is particularly the case unless the shipment is very small (weighing less than 10 kg) of low value (under US\$30.00) and consists of non-restricted items. In other cases, we advise sending the shipment via normal airfreight instead.

If the courier shipment is detained by Thai Customs, we will require all relevant documentation from both the courier company and the shipper. We will then proceed with the import customs clearance process as normal airfreight shipment, which typically takes approximately 1-2 weeks. Please note that our handling fee for airfreight shipments will also apply.

If the courier shipment contains any restricted items, we may need to obtain an import license from the relevant government authorities. The licensing process typically takes a minimum of 5 working days, but it can extend up to 3 months, depending on the specific agency.



Additionally, some restricted items may be prohibited from import into Thailand. We recommend sending us a list of the items in advance to verify any potential restrictions before proceeding with the logistics process.

We do not recommend sending any courier shipments directly to the hotel or venue, as they are not registered with the Customs Department as authorized importers. In the event that your courier shipment is detained by Thai Customs, the hotel or venue will not be able to manage the customs clearance process or facilitate its release from Customs.

If an exhibitor or sponsor chooses to send their shipment via courier service, they do so at their own risk, acknowledging that APT has no control over the potential detention of the cargo or delays in its delivery.
